2013 Winter Meeting—Record Setting Numbers

The 2013 Winter Meeting in New Orleans, Louisiana, was the most successful meeting for the LVMA. The meeting was attended by 416 veterinarians, 91 veterinary technicians and students and 83 vendor representatives. There were a total of 627 people in attendance throughout the weekend!

The meeting featured 20 hours of continuing education for veterinarians and 10 for technicians. There was also an auxiliary tour to the New Orleans School of cooking, an awards ceremony with a presentation by Dr. David

This information is critical to our success with the legislature.

By all accounts, the LVMA Winter Meeting last month in New Orleans was the best-attended meeting in our history! We had 416 veterinarians in attendance, 91 veterinary technicians and students, and 83 vendor personnel. Total attendance for the weekend was 627 people. The growing attendance at LVMA Meetings in recent years is a great tribute to the hard work of our program committee, with Drs. John Mauterer, Sue Olivier and Dale Peyroux lining up the companion animal and practice management sessions, Drs. Darren Schilling and Shannon Gonsoulin on the Food Animal track and Dr. Bruce Eilts in Equine. We will need a replacement for Dr. Eilts as he has gone west.....way west, to Australia. We will miss his leadership and commitment.

Back by popular demand this year will be the LVMA Free Seminar on June 2, 2013 at the LSU SVM. Dr. Robert Lofton has lined up Dr. Valarie Fadok to present "A Day In Dermatology: Covering the Problems That Affect Your Patients and Frustrate You!" We will be opening registration soon for this seminar.

AVMA Delegate Report

The AVMA House of Delegates (HOD) recently convened its annual winter session in Chicago, Illinois, January 4th and 5th, in conjunction with the AVMA Veterinary Leadership Conference. Drs. Wayne Roberson and David Hesse represented the LVMA in the HOD. Seven resolutions and one by-laws amendment were considered, and reports from the AVMA officers, treasurer and governance review task force were presented.

The treasurer reported that AVMA membership is now over 84,000 veterinarians and continues to grow each year. A net surplus of income over expenses was achieved for fiscal year 2012, and a net income surplus is again predicted for the 2013 budget. The Executive Board (EB) approved \$80,000.00 of the latter for a marketing campaign for AVMA approved internships. Other EB actions include a future online survey of practitioners regarding recent graduate qualifications, a task force to study antimicrobial use in small animals, and a study to update the AVMA logo.

Resolutions considered and acted upon by the HOD were:

- 1) Approved to remove designated professional category requirements to be a member of the HOD's House Advisory Committee (HAC). Now all HAC positions are at-large, and no more than one member from the same state or allied organization is allowed on the committee.
- 2) Approved a revision to the policy on the Veterinary-Client-Patient Relationship to include oversight of treatment, compliance, and outcome.
- 3) Referred a resolution to the Executive Board that would declare homeopathy to be ineffective and its use discouraged. The HOD requested the EB refer this resolution to the Council on Veterinary Services for further consideration.
- 4) Approved that canine devocalization be performed only as a final alternative to euthanasia, after behavioral modification to correct excessive vocalization has failed, and the owner has been adequately advised of potential complications.
- 5) Approved a new policy statement regarding the proper use of mechanical aids to direct livestock movement.
- 6) Approved a revision of the current policy on the use of pluripotent stem cells.
- 7) A revision to the current policy on microchipping and electronic identification was withdrawn by the EB, preventing consideration by the HOD.

A by-laws amendment which changes the way membership will be notified of future by-laws changes was approved by the HOD to include



notification via the AVMA website. All of the above actions and resolutions will be available for viewing on the website shortly.

The task force on AVMA governance presented preliminary ideas to change the overall representation of the membership at the governance level by providing for election of all officers by general membership vote, replacing the current EB/HOD governing structure with a 17 member board elected by the membership with no geographic limitations to representation on the board, and providing all veterinary students the right to vote on all AVMA matters. The task force received numerous comments on these proposals and will continue to evaluate what changes, if any, need to be made to AVMA's governance structure. Your opinions on these changes are welcome and can be made to Dr. Chip Price, Executive Board member for district 8 (Louisiana, Texas, and Arkansas), or Dr. Wayne Roberson, your new AVMA delegate (previous alternate delegate). A new alternate delegate will be appointed by the LVMA Board of Directors in the next few weeks. If you are interested in this position, please let your intentions be known to the LVMA office as soon as possible.


