Re: Act 615, (SB 607)

As required in Act 615 (Senate Bill 607), created in the 2006 Regular Session, and signed by the Governor, I am requesting a copy of the evacuation plan for the entities listed above that normally house household pets, research animals or service animals.

This act also requires that your plan be filed with your parish office of homeland security and emergency preparedness. Your plans are required to be filed with both agencies annually.

Next year, we would request submission of your plans by **May 1, 2007**.

Federal groups like the United States Public Health Service and USDA Animal Care are assisting the state in providing information on evacuation and sheltering and identification of sheltering areas.
